



# Resolutions from the 232nd Ordinary Meeting of the Executive Management Committee (Gecex)

## I. Approval of Minutes

- The minutes of the 231st Ordinary Meeting of Gecex were approved.

## II. Trade Defense and Public Interest

a) The proposal to apply provisional antidumping duties on imports of polyester fabrics originating from China remains on the agenda of Gecex.

b) The proposal to apply a definitive antidumping duty, for a period of up to 5 (five) years, to Brazilian imports of fiber optic cables originating from China was approved.

c) The proposal to modulate the antidumping duty applied to Brazilian imports of fiber optic cables originating from China, due to public interest, to US\$ 2.42/kg, was approved.

d) The proposal to apply a definitive antidumping duty, for a period of up to 5 (five) years, to Brazilian imports of optical fibers originating from China was approved.

e) Approved the proposal to extend the definitive antidumping duty, for a period of up to 5 (five) years, applied to Brazilian imports of nylon yarns originating from China, South Korea and Chinese Taipei.

f) The proposal to extend the definitive antidumping duty for a period of up to 5 (five) years, applied to Brazilian imports of tableware originating from China, was approved.

g) Approved the proposal to extend the definitive antidumping duty for a period of up to 5 (five) years, applied to Brazilian imports of new rubber tires for passenger cars originating from Thailand and Chinese Taipei, with the immediate suspension of the application of the antidumping duty with respect to Chinese Taipei.

h) The proposal to extend the antidumping measure applied to Brazilian imports of automotive glass originating from China, established by CAMEX Resolution No. 5/2017, to the Malaysian company Xinyi, was approved, due to the conclusion of the anti-circulation review.

i) The proposal to apply a definitive antidumping duty, for a period of up to 5 (five) years, to Brazilian imports of colorless float glass originating from Malaysia, Pakistan and Turkey, was approved.

j) The proposal to grant the request for reconsideration from Wanli Tire Corporation Limited was approved.

I) The proposal to suspend the antidumping duty applied to Brazilian imports of gloves for non-surgical procedures, originating from China, Malaysia and Thailand, was approved due to public interest.

(i) Claim registered within the scope of the shortage mechanism, but Gecex accepted the CAT recommendation and approved the migration to Letec, given that there is already a tariff reduction in effect for the NCM in question.

(ii) Claim registered within the scope of the shortage mechanism, as a review for the purpose of increasing the quota, but Gecex accepted the CAT recommendation and approved the migration to Letec, with a quota equal to the requested increase and validity until the end date of the claim currently in force in the shortage mechanism.

(iii) The request was for a quota of 300,000 tons, but Gecex accepted CAT's proposal and approved a quota of 200,000 tons, for a period of 6 months.

**IV. Exemption Concessions for BK, BIT and Self-Propelled BK**

- *The inclusion of 1,206 (one thousand two hundred and six) Ex-tariff items in the Single Annex of Gecex Resolution No. 780/2025 has been approved. Of this total:*
  - **280 exceptional extensions** of the validity period (until 03/31/2026) of Ex-tariffs;
  - **797 renewals** of Ex-tariffs (valid for up to 2 years);
  - **129** new Ex-tariff concessions; and
  - **1 amendment** to the wording of 1 Ex-tariff item contained in the Single Annex of Gecex Resolution No. 780/2025.
- *The inclusion of 119 (one hundred and nineteen) BIT tariff exemptions in the Single Annex of Gecex Resolution No. 781/2025 was approved, distributed as follows:*
  - **36 exceptional extensions** of the validity period (until 03/31/2026);
  - **78 renewals** of Ex-tariffs (valid for up to 2 years); and
  - **5** new Ex-tariff concessions.
- *The inclusion of 3 (three) Self-Propelled BK Ex-Tariffs in the Single Annex of Gecex Resolution No. 311/2022 was approved, all of which are new Ex-Tariffs. In addition, the wording of 1 Ex-Tariff included in the Single Annex of Gecex Resolution No. 311/2022 was amended.*
